#### **POSITION SUMMARY**

As a full-time member of the Physical Literacy team, the Physical Literacy Supervisor oversees the part-time Physical Literacy Leaders and full-time Physical Literacy Programmer(s). The position is responsible for scheduling, payroll and communication with all members of the Physical Literacy team regarding their shifts and job responsibilities. Communication with the team is conducted through email, phone, in-person meetings, reviews and in-program mentoring. The position also communicates with community organisations to understand changes in program dates, times and protocols for upcoming programs, as well as supports the Coordinator with any necessary tasks needed for the efficient running of the department.

- Supervise Physical Literacy Programmer(s) and Leaders and manage staff schedules, shift coverage, payroll and staff discipline as necessary
- Communicates directly with staff for scheduling, shift coverage and other matters relating to their role
- Conduct portions of staff training; including meetings, Summer Camp training, etc.
- Ensure quality and consistent programming of all PISE physical literacy Programs
- Facilitate physical literacy programs in the community and collaborate with community organizations to schedule programs
- Reports any accidents or incidents to proper facility personnel and Physical Literacy Coordinator
- Supervise the successful facilitation and engagement of PL staff in any special events
- Help organize and facilitate professional development / presentations for community members and staff related to Physical Literacy
- Oversee any necessary development, administration and scheduling for future events or programs not currently operating
- Assist with any tasks or responsibilities deemed necessary for the completion of community programs and success of the Physical Literacy Department
